President's Report



A sad beginning to the year

The Executive Committee, staff and members of the Association began the year with a deep sense of loss after the death of Kyla Jones in a traffic accident in December 2022.

Kyla had been our Manager of Operations and Industry for six years and was well known, loved and highly respected throughout the plumbing and gasfitting industry. There is a full tribute to her on another page of this annual report.

Not only was Kyla's death a tragedy that took away a wonderful human being who was an energetic and talented leader, but her absence also placed our small, hardworking office team under additional pressure. I sincerely thank them for the way they adapted to difficult circumstances and shouldered the extra workload.

The industry's challenges continue

The plumbing and gasfitting industry continues to face the same difficulties that have been a feature of the Australian building and construction sector in recent years.

There is no end in sight to the shortage of skilled tradespeople. On one hand, we aren't training enough apprentices in Australia and on the other hand, skilled migration is hampered by factors such as the shortage of housing and our inefficient visa system.

The skilled migration situation is especially grim here in WA due to our chronic inability to provide skills gap assessments and skills gap training. The various state and national government departments that are responsible for separate parts of the process work in silos and no central organisation is responsible for overseeing everything. It is optimistic to think the national migration strategy, which the Australian Government released in December, will make any difference in the short or medium term.

Meanwhile, the apprenticeship completion rate stays at around 50 per cent year after year. In the long term, with an ageing workforce and too few apprentices to replace retiring plumbers and gasfitters, our industry will be unable to deliver the services the public needs. We need to find ways to make a career in plumbing and gasfitting sound exciting for young people.

Gas

At a national level, a concerning development is the introduction of laws in Victoria and the ACT to ban the installation of gas appliances. These laws, which aim to reduce greenhouse gas emissions, will reduce consumer choice and undermine the development of a clean renewable gas industry without necessarily doing anything to help the environment.

While we face no such threat in WA, this Association is ready to respond if the situation changes. We are also engaged with a range of stakeholders who are working on ways to prepare our industry for the training and up-skilling that gasfitters will need when renewable hydrogen gas is distributed into the gas network in the future.

Positive developments with codes and regulations

The 2022 Plumbing Code of Australia, which is part of the new National Construction Code, came into effect on 1 May 2023, although there are transition periods for



some provisions such as the 0.25 per cent limit for lead in plumbing products.

In June, the WA Government announced it would introduce long-awaited changes to plumbing regulations to align them with the Plumbing Code of Australia and bring us closer to implementing the recommendations of the Building Confidence report.

This Association fully supports both developments and is proud to have played a role in bringing them about by engaging with governments and industry bodies for many years.

Our growing strength

Looking back over everything that has happened this year, I am proud of what this Association stands for and what we do for our members in particular and the industry in general. My only regret is when I look at all the licensed plumbing contractors in WA who aren't members but get a benefit from our policy work and lobbying activities.

In my report last year, I noted that our steadily rising public profile and strong and growing membership made me confident of our continued success. A year later, I still hold this view.

This Association gives licensed plumbing and gasfitting contractors in WA a body that represents them and gives them a united voice. We are the only organisation in WA that exists purely to represent them, assist them in the running of their business, and promote them to the public.

Murray Thomas and the team he leads have done a superb job in adjusting to the loss of Kyla Jones and delivering excellence in our operational activities. As a result of their dedication and commitment, the Association has finished another year in an extremely solid position and are poised to deliver more for the industry next year.

Chief Executive Officer's Report



Another year of steady progress

I am pleased to report another successful year across all areas of the Association's operations.

Our membership numbers continued the upward trend that began last year and our finances are in excellent shape. Our financial health reflects both the solid membership base and the advertising and sponsorship support we receive from our Associate Members.

Notable events and achievements

As I look back over everything we accomplished this year, some highlights really stand out from everything else.

In March, we celebrated World Plumbing Day with a well-attended industry event at Ascot Racecourse. Also for World Plumbing Day, I was a guest on Radio 6PR and spoke to listeners who called in about their experiences with plumbers. This entertaining and informative session created publicity for the Association and allowed me to talk directly to consumers about the importance of a regulated plumbing industry.

In April, we travelled to Kalgoorlie for the first event in our annual series of Industry Information Forums for plumbers and their staff. Behind the scenes, however, we were working on a plan to reach a wider audience and had initiated some important discussions with the Department of Training and Workforce Development and Principals of the TAFE Colleges that conduct plumbing apprentice training.

As a result of the discussions, we established a working relationship with those TAFE Colleges and transformed the traditional Industry Information Forums into Industry Trade Days, which are bigger events that take place on TAFE campuses.

The first Industry Trade Day was at North Metropolitan TAFE Balga Campus in July. This was attended by Training Minister Simone McGurk, more than 150 plumbers and apprentices, and representatives of the many generous companies that supported the event.

Other Industry Trade Days followed at Central Regional TAFE Geraldton Campus in September, South Metropolitan TAFE Rockingham Campus and South Regional TAFE Bunbury Campus in October, and South Regional TAFE Albany Campus in November.

The aim of this collaboration is to create better lines of communication between TAFE teaching staff who provide classroom training, licensed plumbing contractors who give apprentices their practical training, and suppliers of plumbing products. I sincerely thank the Minister McGurk, DWTD Director General Karen Ho and the staff of the TAFE Colleges for engaging with us in this important endeavour.

Post-apprenticeship continual professional development is another important topic for us, so in May we launched the Master Plumbers WA Learning Resource Hub. This online training centre, which is available to the entire WA plumbing industry, has a wide range of short courses for licensed plumbing contractors, licensed plumbing tradespeople and plumbing apprentices. The courses cover topics such as the National Construction Code, Australian Standards, work health and safety, technical information, technology and business management.

I want to acknowledge the support of the Construction Training Fund, which has subsidised the cost of courses on the Hub.



In July, we launched our annual Awards for Excellence competition, which as usual attracted a high standard of entries for the judging panel to consider. The high point of the Awards for Excellence came in November with the Awards Presentation Night, which was a wonderful social occasion that celebrated the achievements and professionalism of our members.

Another highlight in July was when Radio 6PR contacted me to arrange an interview immediately after we published a media release about the WA Government's decision to amend WA's plumbing regulations. The Government's decision was one of the final steps in the regulatory reform process that began over a decade ago. The interview on 6PR was another opportunity to inform the listening audience about the importance of plumbing regulations and why they should use Association members.

In August, I had an interview on ABC Radio Perth on the topic of bidets, which had been getting some media coverage. Again, this was an opportunity to educate the public and promote the Association.

October saw us hosting the annual President's Cup Golf Day. As always, this was an extraordinarily successful, soldout social day for members and their guests.

As the year drew to a close, we were preparing to roll out a new automated membership system, which had been under development for several months. We launched the new system in December and it immediately delivered results in the form of administration efficiencies and an improved membership experience.

Once again, I want to finish my report with some important acknowledgements.

I want to thank Associate Members for their continued generous support. Very few, if any, of our events would be possible without their involvement as sponsors and advertisers.

Many of our Associate Members also provide our members with discounted products or services. These are valuable benefits and I encourage all members to do business with Associate Members whenever possible.

Remembering Kyla Jones

In December 2022, Kyla Jones, who had been our Manager of Operations and Industry for six years, died after being the victim of a traffic accident.

Kyla was one of the most respected people in the Australian plumbing industry, in which she had 30 years' experience.

She was a dynamic leader whose energy, dedication and strategic thinking were responsible for lifting the performance of the Association and transforming the quality of the services we provide to members.

Kyla was also known for her strong convictions about the importance of plumbing and the need for qualified plumbers to be recognised as professionals who protect public health and the environment.

Approximately 300 people from all sectors of the plumbing industry attended Kyla's funeral service. They included interstate industry figures who made the long journey across Australia to Perth.

In December 2023, at the Awards for Excellence presentation night where people from across the industry had gathered to acknowledge the highest levels of achievement and professional commitment, we posthumously inducted Kyla into our Hall of Fame.

In another permanent tribute, the Customer Service Excellence category in the Awards for Excellence was renamed 'Kyla Ann Jones Memorial – Customer Service Excellence' category.

By naming an annual Award category after Kyla and inducting her into the Hall of Fame, we are ensuring she will always be remembered.

Major Achievements

CTF Funding for Master Plumbers WA Learning Resource Hub

We were successful in securing Construction Training Fund (CTF) support for the courses on our Master Plumbers WA Learning Resource Hub, which we launched in 2022.

The Learning Resource Hub contains an extensive range of short online training courses and other resources that are available to everyone in the industry. The CTF funding allowed substantial reductions in the cost of most courses.

Our investment in the Learning Resource Hub reflects our belief that continual learning is essential for licensed plumbing contractors. We are continuing to advocate for the introduction of mandatory continual professional development.

TAFE collaboration and Industry Trade Days

As a result of a successful collaboration initiative with TAFE, our annual Industry Information Forums series transformed into Industry Trade Days at regional and metropolitan TAFE College campuses.

This collaboration is bringing TAFE trainers and apprentices into closer contact with licensed plumbing contractors and other industry stakeholders. The result will be a more unified approach to apprentice training and a greater awareness among licensed plumbing contractors of the quality of modern training facilities at TAFE Colleges.

Online membership applications and renewals

In December, we launched an online membership system that has made sign-ups and renewals fast, easy and secure. It has replaced the old manual invoicing system that was inconvenient and time consuming for new and renewing members.

By automating many of the processes related to membership management, the new system has also streamlined our office administration workload.

World Plumbing Day celebration

Every year, March 11 is World Plumbing Day. It is the most important event on our calendar and we always seek to celebrate it in a meaningful way that engages our members. Because World Plumbing Day fell on a Saturday this year, we hosted an event at Ascot Racecourse that was attended by over 100 members and guests. One of the races on the day's program was named the World Plumbing Day Celebration Handicap.

Awards for Excellence

The annual Awards for Excellence competition attracted much interest and the gala awards presentation night was very well attended. An innovation this year was an improved streamlined online entry system.

The post-event publicity included a full page pictorial feature in The West Australian with photos of the winners.

We thank all entrants, the judges and our generous sponsors for supporting the Awards for Excellence, which is WA's only such competition conducted by an organisation that represents licensed plumbing contractors.

President's Cup Golf Day

Our annual President's Cup Golf Day is always a popular social event for our members and their guests. This year's event was at Wembley Golf Course in October. Once again, the day was sold out well in advance and was an outstanding success for our sponsors, members and their clients.

Leak detection program

This partnership with Water Corporation delivers leak detection services to commercial properties where the metered water consumption is unusually high and indicates the presence of major underground leaks.

Because the size of the properties and the complexity of their underground pipe systems rules out conventional leak detection methods, the program involves a select group of five contractors who own and operate specialised leak detection equipment. Three of these five contractors are Association members.

We participated in the selection of the contractors and the day-to-day operation of the program, which will be ongoing. So far, the program has been responsible for detecting and repairing leaks that we estimate were responsible for losing a minimum of 15 million litres of water annually.



Media exposure

Positive media exposure is essential for enhancing the brand of the Association and publicising our policies. We were in the media several times this year.

An article in The West on Tuesday 26 September featured our distinguished member Bill Busby and his first-hand account of the impact of the skills shortage. The article also included a call from our CEO Murray Thomas for a reduction of red tape around employing skilled migrants. Murray Thomas was interviewed about plumbing topics a number of times during the year on ABC Radio Perth and Radio 6PR.

We also published media releases during the year. These related to the launch of our Plumbing Industry Trade days, the need for the WA State Budget to include funding for much-needed construction industry reforms, and the Government's announcement of reforms to plumbing regulations.

Engagement with Government

Our CEO Murray Thomas is a member of the Western Australian Building and Construction Consultative Committee (BCC Committee), a forum for major industry stakeholders to discuss and provide advice to the State Government on issues in WA's commercial construction sector.

The WA Government established the BCC Committee in June 2022 because it recognised the need for a high-level communications channel with employers, representative associations and unions in the commercial construction sector. The BCC Committee meets quarterly and has a focus on economic, industrial relations, safety, diversity and workforce management matters. It also has a key role in stimulating building activity, skills development and jobs growth.

Our government engagement also resulted in our collaboration with TAFE for the Industry Trade Days.

Policies

Our management team engages with ministers and other decision makers in the WA Government and Australian Government to ensure our industry's needs are heard.

We also take every opportunity to provide the media with the industry's point of view and bring critical issues to their attention.

Although we represent signed-up members only, the entire plumbing industry in Western Australia benefits from our activities. This year our efforts were rewarded when the WA Government announced amendments to the plumbing regulations that will finally bring them into alignment with the Plumbing Code of Australia. This reform has been on our policy agenda for many years.

Currently, our primary policy focus is mandatory continual professional development for licensed plumbing contractors.



Submissions

In October, we assisted our industry's national peak body, Master Plumbers Australia and New Zealand, with the preparation of a submission to the Department of Employment and Workplace Relations about Skilled Migration Assessing Authorities. The document, which was a detailed formal response to a discussion paper, included content we had prepared about issues with skilled migration into Australia in general and WA in particular.

We also provided our own independent submission.

Both the MPANZ submission and ours drew attention to the fact that WA has no Skilled Migration Assessing Authorities to conduct assessments for overseas-trained plumbers and gasfitters. This means it is virtually impossible for skilled migrants to be assessed, which in turn means they cannot gain their provisional licences and become employed in WA.

Looking Ahead

We anticipate another year of steady membership growth. Two key factors that will contribute to this are publicity generated by Industry Trade Days and media exposure, and our new online membership renewal system, which has enhanced our ability to attract and retain members.

We are also planning to refresh our web presence and enhance our online engagement with licensed plumbing contractors and the public, with the aim of increasing our profile with both audiences. There will be another series of the Industry Trade Days that began this year in partnership with TAFE. These events are now a permanent feature of our annual calendar.

On a less optimistic note, we expect the industry's serious challenges with skilled labour shortages and skilled migration will continue indefinitely. We remain committed to doing everything possible to bring about much-needed changes on national and state levels.
